2018 Connect Logistics Service Rate Structure

The Board of the Alberta Gaming and Liquor Commission (AGLC) has approved the 2018 rate structure proposed by Connect Logistics Services, Inc. (Connect). Under the terms of the agreement with the AGLC, Connect must supply the AGLC with a proposed budget to determine the rate structure for the upcoming year.

The warehouse network transition, including moving into the AGLC's new warehouse in the fall of 2018, is well underway. This transition is taking place during a challenging period for Alberta's economy. The result is that there is upward pressure on "per case" operating costs as the fixed costs and incremental transition costs are being distributed over fewer cases moving through the network. Connect has taken every possible measure to ensure the impact to the industry is minimal. However, in 2018 some key rates will increase by approximately 1.0% to cover supply chain costs. Attached is a complete schedule of the new rates that will take effect December 31, 2017.

Connect will continue to support the open Alberta liquor model by offering superior service, regardless of transition, at the lowest possible cost to Retailers, Agencies, and Suppliers in Alberta.
